DBDCDT & DBCC Local Place Plan Questionnaire

This questionnaire gives you an opportunity to have your say on the future of our communities.

The Scottish Government and local authorities - including Perth and Kinross Council (PKC), take a 'plan-led' approach to decision-making on development. As part of this a new National Planning Framework (NPF4) was adopted in February 2023. Designed to link to the United Nations Sustainable Development Goals, this Framework is supplemented by plans at a more local level. These include a PKC Local Development Plan, such as that developed in 2019 for our area, and due to be updated in the coming months. The 2019 Development Plan includes a Settlement Plan (map) for Dunkeld & Birnam.

Ahead of the revision of the PKC Development Plan, we have the opportunity to develop our own, community-led, **Local Place Plan** - this can set out what is important to our community, opportunities to strengthen it, and to be specific about locations for action - our submission will likely include a map. PKC will be required to have regard to our plan, so it is important it can be as representative as possible of views in our community. This questionnaire - run in partnership by the Dunkeld and Birnam Community Council, and the <u>Dunkeld, Birnam & District Community Development Trust</u> - builds on work carried out to develop our Community Action Plan 2022-27.

Each section of the questionnaire is illustrated by a map which shows comments we have received during our initial consultation period. These are included as a means to stimulate thoughts and provoke suggestions.

Please answer all the questions you feel are relevant and leave out any which are not.







Infrastructure first

Policy Principles

Policy Intent:

To encourage, promote and facilitate an infrastructure first approach to land use planning, which puts infrastructure considerations at the heart of placemaking.

Policy Outcomes:

Infrastructure considerations are integral to development planning and decision making and potential impacts on infrastructure and infrastructure needs are understood early in the development planning process as part of an evidenced based approach.


- Existing infrastructure assets are used sustainably, prioritising low-carbon solutions.
- Infrastructure requirements, and their planned delivery to meet the needs of communities, are clear.

Local Development Plans:

LDPs and delivery programmes should be based on an integrated infrastructure first approach. Plans should:

- be informed by evidence on infrastructure capacity, condition, needs and deliverability within the plan area, including cross boundary infrastructure;
- set out the infrastructure requirements to deliver the spatial strategy, informed by the evidence base, identifying the infrastructure priorities, and where, how, when and by whom they will be delivered; and
- indicate the type, level (or method of calculation) and location of the financial or in-kind contributions, and the types of development from which they will be required.

Plans should align with relevant national, regional and local infrastructure plans and policies and take account of the Scottish Government infrastructure investment hierarchy and sustainable travel and investment hierarchies in developing the spatial strategy. Consistent early engagement and collaboration between relevant stakeholders will better inform decisions on land use and investment.
