PH8 VISION 2037

Dunkeld, Birnam and surrounding communities are thriving, well connected, safe and resilient, with a healthy, flourishing and accessible natural environment. Transitioning towards self sufficiency in energy and as a model for locally grown food, residents and visitors alike are housed in appropriate, affordable and suitably sited accommodation, with access to a rich variety of shops and services. Our communities offer sites for sustainable and vibrant business and third/ charitable sector activity, adding to the richness of heritage and history which make this place so unique. Our citizens have opportunities to live active and healthy lives, with the fabric of our community underpinned by a sound, representative and community minded model of civic governance.



Executive Summary

This Local Place Plan (LPP) report is the result of a community consultation with the people of PH8 (Dunkeld, Birnam and District) that took place during the three months from November 2024 to January 2025.

It is an initiative developed in partnership with Dunkeld Birnam and District Community Development Trust (DBDCDT), Dunkeld and Birnam Community Council (DBCC) and Perth and Kinross Council (PKC). No external funding support was found, so the process has been managed entirely by volunteers from DBDCDT, DBCC and other members of the community.

The LPP considers how PH8 should develop in the next 12 years, through to end of the next Local Development Plan (LDP), building on the consultation work carried out in the development of the Community Action Plan (CAP) finalised in 2022.

The process garnered a very wide range of suggestions from the community for the future of PH8. As well as informing this LPP, the results will provide the DBDCDT, the DBCC and other community focus groups with invaluable insight into community priorities and future projects, at a greater level of detail than in the original CAP. It will inform the continuing dialogue between all community partners, PKC and agencies such as Transport Scotland(TS) and Historic Environment Scotland (HES).

The three major areas of community concern are Traffic and Parking infrastructure in and around Dunkeld and Birnam, especially during tourist seasons and at weekends, and the availability of Affordable Housing. Although many people acknowledged the need for affordable housing, given the infrastructure challenges, there was strong opposition to that being provided via a major new housing development.

This report, highlighting community priorities, was presented as a final draft at two community engagement events held on 26th and 28th March 2025. Attendees were encouraged to leave comments, but none were received that challenged the major conclusions of the report, which remains as originally drafted.

A summary of these events is presented on page 47 and all the comments captured by members of the public are presented in Appendix 4.







Introduction

This Local Place Plan was prepared in conjunction with the Dunkeld & Birnam Community Council and the Dunkeld, Birnam & District Community Development Trust with support from Perth & Kinross Council.

In preparing this Local Place Plan we have been guided by both 'Scottish Government Circular 1 – Local Place Plans' and 'Planning Aid Scotland Guide for Community Delivery of Local Place Plans'. We understand the deliverables that are required for this Local Place Plan to be formally registered and have, within this document, provided that information.

It sets out background information about the PH8 community, explains the consultation process that has been undertaken, presents a detailed breakdown of the communities and concludes with a summary statement and proposals for moving forward on a range of issues raised.

Creating a Local Place Plan is an opportunity to consult with the community and create a shared vision for future development. This Local Place Plan will be updated over time as the needs and aspirations of the community evolve.











Local Place Plans

The right for communities to produce Local Place Plans was created in 2019 by new planning legislation allowing communities to set out their ideas for the development and use of land in their area. Local Place Plans are intended to be solutions-focused, realistic, deliverable and as specific as possible. They are a tool for local communities to think about how to improve their local area, tackle the challenges they face, agree priorities, and act.

The Town & Country Planning (Scotland) Act 2015 and The Town & Country Planning (Local Place Plans) (Scotland) 2021 Regulations set out the steps that must be taken in the preparation of a Local Place Plan.


- The Local Place Plan must have regard to other plans (or emerging plans) such as the Local Development Plan, the National Planning Framework and the Locality Plan, where there is one.
- The Local Place Plan must set out in a statement any reasons for considering that the Local Development Plan should be amended.
- It should refer to other local, national or regional plans or strategies which may be relevant as well as planning permissions which may have a significant impact on the local area.
- Local Place Plans should be short, clear and visual, setting out proposals and priorities.

PH8 Local Place Plan Area

It is a requirement of a Local Place Plan that the area to which the plan relates is clearly set out. This Local Place Plan covers the postcode area of PH8 in Perth & Kinross (bounded & hatched in magenta on the adjacent map) together with 9 no. PH9 postcodes within the zone noted A on map. These are;

These postcodes include the settlements of Dowally, Guay, Kindallachan and Tullimet.




The Planning System

The planning system in Scotland is plan-led. Plans set out how places will change, where development should and should not happen and places that should be protected. Plans guide decisions on applications for planning permission.

The Town and Country Planning (Scotland) Act prescribes four different levels of plan:

- The National Planning Framework (NPF). This sets out Scottish Ministers' policies and proposals for the development and use of land.
- Regional Spatial Strategies (RSS). Long-term strategies for the strategic development of an
 area prepared by a single planning authority, or a number of planning authorities working
 together.
- Local Development Plans (LDP). Prepared by local planning authorities, showing how their area will change, including where development should and should not happen.
- Local Place Plans (LPP). Community-led plans setting out proposals for the development and use of land in a local area.



This Local Place Plan has been prepared in advance of Perth & Kinross Council's new Local Development Plan (LDP3) 2027 so that it can influence the development of LDP3. The current settlement boundaries for Dunkeld and Birnam, as set out in LDP2 are shown in figure 3 below. The settlement summary text from LDP2, that accompanies the settlement plans, is as follows;

'The towns of Dunkeld and Birnam are located on opposite banks of the River Tay joined by the historic Dunkeld Bridge.


Tourism is important for employment and maintaining the viability of services. The Plan therefore seeks to protect and retain existing employment and tourism uses.

Dunkeld and Birnam are identified together in TAYplan as a Tier 3 Principal Settlement. However, the potential for additional development is highly constrained by potential flooding, the surrounding topography, and by various international and national natural and built heritage designations surrounding the towns. Development allocations are therefore limited to additional employment sites at Tullymilly which will help to consolidate and encourage future opportunities for sustainable economic growth there.

There may also be scope for some small-scale infill residential development.

The future dualling of the A9 has the potential to bring positive economic benefits to the area although the land use implications of the project are not yet clear. The settlement lies partly within a HSE Pipeline Consultation Zone. Development may therefore need to comply with Policy 54: Health and Safety Consultation Zones.'

PH8 Location

The PH8 area lies approximately 15 miles north-west of Perth. The twin towns of Dunkeld and Birnam, where the population of PH8 is concentrated, are adjacent to, and served by, the main A9 trunk road and the Highland Line rail route between Perth and Inverness. It has been called the "Gateway to the Highlands" due to its location on the Highland Boundary fault but also because of its proximity to a large swathe of central Scotland to the south, and the easy access afforded by the trunk road and rail networks, and the highlands to the north.

This location, and the beauty of the natural environment, has fuelled our popularity both as a visitor destination and as an attractive place to relocate and still be within commuting distance of the main centres of population. These attributes have contributed to the vibrant community and thriving economy which we now have. However, there is also a sense, as evidenced in the public consultation, that we have perhaps reached, and sometimes breached, the capacity of our infrastructure to absorb these visitor numbers.

Dunkeld and Birnam's hinterland contains several small settlements, three of which have their own village halls. Historically they have looked to Dunkeld & Birnam for their community facilities, services and shops but, more recently, residents in the PH8 hinterland have reported that they avoid coming to Dunkeld & Birnam at busy times because of the congestion and near impossibility of finding parking.



Natural Environment

Overall, the natural environment of the PH8 area is a mix of fertile and grazing farmland, rich woodlands, and scenic rivers and hills, making it a picturesque and ecologically diverse area. Of the key settlements, Dunkeld lies on the north bank of the River Tay with Little Dunkeld and Birnam situated on the southside. The towns nestle between three steep wooded hills, namely Birnam Hill, Craig-y-Barns and Newtyle Hill. This gives the area its unique character which is reflected in its designation as the River Tay (Dunkeld) National Scenic Area (NSA). There's no doubt however that the beauty of this geography, recognised by the many, overlapping protected areas, also imposes limits and constraints on the community when it comes to change.


The special qualities described by NatureScot include;

History & Heritage

The historic and heritage environment of Dunkeld, Birnam, and the surrounding PH8 area is a fascinating tapestry of medieval religious sites, literary connections, natural beauty, and architectural landmarks. The region is not only rich in historical significance but also offers visitors a deep connection to Scotland's past, making it a unique and culturally important part of the country.

The ancient burgh of Dunkeld clusters around its 13th century cathedral and Market Cross (now replaced by the Atholl Memorial Fountain). The famous late 17th century 'Little Houses', restored by the NTS in collaboration with PKC over a period of 15 years in the mid-20th century, create a unique charm. Dunkeld Bridge built by Thomas Telford between 1805 and 1809 is a much photographed seven-arch structure. Its construction altered the orientation of Dunkeld from the east-west axis of Brae, High and Cathedral Streets leading to the cathedral, to a north-south axis across Dunkeld Bridge into Bridge and Atholl Streets, now Dunkeld's main artery. The narrowness of this ancient bridge is a concern for safe active travel.

Birnam is largely Victorian, developed after the construction of the railway line and the station in 1856, and is well known for its literary connection with Shakespeare's Macbeth and Birnam Wood. Niel Gow, a famous local fiddler and prolific composer who lived in Inver in the 1700s, is memorialized in a statue. An annual festival in his name draws people from all over Scotland and beyond. Beatrix Potter's family had strong links with Dunkeld and the surrounding countryside having holidayed here for many summers.

The surrounding settlements to Dunkeld & Birnam all have noteworthy places, monuments and landscapes of historical significance including the scheduled monument of Trochrie Castle in Trochry, Amulree and Strathbraan Church and Charleston at Dalguise.




















History & Heritage

It is not surprising then that the P8 area has become ever more popular as a place to live and to visit, both for day trippers and longer stay visitors. They come to enjoy the beautiful landscape, visitor attractions such as the Hermitage and Loch of the Lowes, and the historic sites and stunning setting of Dunkeld and Birnam. The intensity of nationally recognised areas of historic value can be clearly seen on the map below.



Services, Community Facilities & Connectivity

Services & Community Facilities: In general, the PH8 area looks to the twin communities of Dunkeld and Birnam which are well served with local amenities. Whilst some of the outlying settlements have community spaces, such as the village halls in Amulree, Butterstone and Dalguise, there are almost no other services, amenities or shops available. Travelling into Dunkeld and Birnam to access these is common but, as has been established in this LPP, parking, congestion and A9 safety issues are making this a less attractive option. An exception to the concentration of amenities is the invaluable network of 14 emergency defibrillators situated throughout PH8. Notable hinterland institutions include Corbenic Camphill Community at Trochry, supporting 100 adults with learning difficulties, the Moore House Academy at Butterstone, providing for young people who need specialist care and education, and PGL at Dalguise House, a large outdoor activity centre catering for young people from all over the UK and abroad. Services are fairly evenly spread between Dunkeld, Little Dunkeld and Birnam as can be seen from the map below. Dunkeld has a higher concentration of shops, cafes and eateries; Birnam has a few shops and Birnam Arts. Shopping locally for basics is provided for by the Coop in Dunkeld and the Local Shop in Birnam. As outlined in the next section, Leisure and Recreation, the richness of the offering in PH8 means that the community benefits, and uses well, all these facilities.

Connectivity: As well as the busy Highland main line train station which links the community to major centres both to the north and south, there are two long-distance buses a day in both directions. The local bus service connects Dunkeld and Birnam with Ballinluig, Pitlochry and Aberfeldy to the

north-west, and Bankfoot and Perth to the south-east. There are two PKC ticketed car parks in Dunkeld with a limited amount of free on-street parking in Dunkeld. In Birnam/Little Dunkeld, there is somewhat more on-street parking but no dedicated public car parks. Parking in both Dunkeld and Little Dunkeld/Birnam has become increasingly problematic at peak weekend/holiday times, with some totally inappropriate parking requiring police intervention at times. There are a range of wheeling and walking paths throughout the community, though accessibility can be an issue in some places. Information connectivity is provided by the monthly newspaper, The Bridge, which is delivered to the outlying village halls and individually to households in Dunkeld and Birnam.




Leisure & recreation

Leisure & recreation facilities are well used and much appreciated. Within the Dunkeld & Birnam area these include a range of sports facilities, play parks, community growing initiatives and a variety of cultural spaces, including Birnam Arts, a thriving local music scene based largely in the local pubs and the Museum and Archive. Birnam Arts provide activities and events from the very youngest to the very oldest. Drama, film, music, creative arts, movement and exhibitions, as well as a venue for annual events such as the Santa day show, the Christmas pantomime and ballet performances. It's also home to the much-loved library. In the outlying villages, the village halls play a central role in providing social, cultural and recreational activities.

The Core Path network is popular with residents and visitors alike and our beautiful setting has become a magnet for hiking, trail & mountain bikers, rock climbers, canoeing, paddle-boarding, fishing and much more. Activity and sports groups and clubs are wide ranging – netball, tennis and 5-asides at the Muga, bowls, football and annual shinty at the Rec, yoga, Pilates, salsa classes, ballet and running to name a few.

An introduction to Dunkeld and Birnam would not be complete without mentioning the many active and committed community groups that flourish. Campaigning groups such as the Birnam to Ballinluig A9 community group, the Junctions Action group and the Station Improvement group; environmental groups such as Birnam in Bloom, the Paths & Nature Action group and our very own Climate Café, started here and now a worldwide movement; a twinning organisation Friends of Asheville (North Carolina); support groups such as the Lunch Club, the Meeting Space and the Men's Shed; plus many sports clubs, music clubs, etc. and lots of classes. There are also annual events such as the Birnam Highland Games, the Niel Gow Festival, the Dunkeld Cathedral Art Exhibition, Dunkeld & Birnam Unplugged, Santa Day and the Birnam Book Festival which are enjoyed by both residents and visitors.





Housing & Energy

Housing across PH8


The population of PH8 is approximately 2400. Dunkeld and Birnam has a population of 1200, with a 3 to 1 split between Little Dunkeld/Birnam (900) and Dunkeld (300). This was calculated from the 2022 census figures and the respective number of households on the Scottish Assessors website.

The historic centres of both Dunkeld and Birnam have conservation area status with 58 and 47 B or C category listed buildings, respectively. There is also a considerable number of non-listed homes dating from before the 1940's. The constraints of topography and environmental and heritage protections in Dunkeld has meant that development of the twin towns over the later half of the 20th C, and into the 21st C, has been mainly focused in Birnam and Little Dunkeld with housing sites such as Stell Park, Willowbank and Inchewan. In Dunkeld, pockets of land to the north of the town have seen some housing development, most notably at Atholl Park and Atholl Gardens.

In the outlying settlements development has mainly been limited to single builds and small size cluster developments usually linked to existing farms and large houses. The ten house development at Inchfield/ Inchmagrannachan, dating from around the 1950's, is probably the largest multi-unit housing site built outside of Dunkeld and Birnam in the last 70-80 years.

Housing & Energy Use

Many of these houses however predate the introduction of formal regulation of housing standards in the 1980's. Whilst Scotland has now evolved from the minimal insulation requirements of that time to having one of the most stringent energy efficiency standards in the world today, there is still a huge challenge in our community to upgrade and 'green' a large percentage of the existing housing stock whether they be private, housing association or council owned. The bar-chart below shows that nearly 80% of houses in Dunkeld & Birnam use non-renewable forms of central heating. Alternative forms of heating will be needed to meet the governments commitments towards the phasing out of oil and gas and the community are already exploring opportunities for alternative sources of renewable energy.



Housing Stock, Short-Term Letting Properties (STL's) and Second Homes

Comparing Dunkeld and Birnam statistics against National ones, in respect of home ownership vs forms of rental, statistics indicates a higher-than-average level of home ownership in the community, a higher-than-average level of private rentals and a lower-than-average level of social/housing association type rentals. House prices across PH8 are higher than the national average across a range of housing types and sizes.

Statistics taken from PKC's 2022 Short Term Lets Evidence Paper shows that STL's in PH8 account for 5.7% of total housing stock with second homes at 5.2%. These levels are higher than the average for Perth and Kinross but less than for Highland Perthshire overall which has a combined percentage of STL's and second homes of 15.5%. Updated figures for STL's, post completion of the national registration scheme initiated in October 2023, are not yet available nor are figures for how the introduction of the 200% rise in council tax for second homes, introduced from April 2024, have impacted.

Affordable Housing

The need to address a range of issues related to housing arose from the extensive consultation which delivered the 2022 CAP, in which housing was identified as a key priority. This included actions around reducing short term lets and second homes, ensuring more affordable housing to buy and rent locally, ownership of land and buildings as community assets, and provision of sheltered and social housing, including options for downsizing.

DBDCDT constituted a Housing Action Group(HAG) sub-committee in 2022 to explore these issues and a Community Housing Needs Survey, conducted by Communities Housing Trust (CHT) in 2022, indicated a need for local affordable housing to purchase and/or rent. The HAG initially focussed on 38 sites within Dunkeld and Birnam which were within the settlement boundaries of Dunkeld & Birnam, thus generally fulfilling the 20-minute neighbourhood policy as detailed in NPF4. PKC ranked these sites using a traffic light system to indicate their development potential. A significant proportion of these sites were rejected because of various geographical and flooding related issues, but a shortlist was presented at an Open Afternoon organised by DBDCDT in April 2024.

In February 2023, Atholl Estates (AE) presented their vision for a 40-acre development of 235 houses at Haughend Farm to the HAG. The HAG minutes recorded that the consensus was that the proposal was unacceptable for a variety of reasons, including that it was too large, that it would seriously damage the natural environment, that the land was not zoned for development and outwith the existing settlement boundary, and that the road, surface and wastewater systems and current amenities could not cope with so many new residents. In November 2023 AE submitted to PKC a Proposal of Application Notice (PoAN) for 40 acres at Haughend following which two public consultation events took place in Birnam Arts in November 2023 and February 2024, showing a proposed development of 65 houses (42 private and 23 affordable) plus workspace on 11 acres. Clarity was sought and given that AE were offering 23 serviced plots to the DBDCDT and that if the DBDCDT could not raise sufficient funds, a Housing Association would build and manage the 23 affordable homes.

In October 2024, an initial meeting was held to ascertain support for a new Housing group to be formed with the aim of progressing further the provision of affordable housing. At the DBDCDT's AGM in November 2024, the new Housing group stated their wish to work independently from the DBDCDT and to call themselves the Community Housing Group (CHG). A survey conducted by CHG in late 2024 echoed the sentiments of the earlier HAG surveys and supported the view that an affordable rent would be in the region of £400 to £600 per month and an affordable purchase price between £150,000 to £250,000.

In February 2025, the transfer of 19 National Trust for Scotland properties to Perth and Kinross Council was completed with former NTS tenants becoming tenants of the Council. All will enjoy a range of associated benefits as a result, including reduced rent levels and a 24-hour emergency repairs service. Arrangements have also been put in place that will see people with a connection to Dunkeld given priority consideration should vacant tenancies arise.

Further progress towards the delivery of more affordable housing within our local community is still required.

Economy

The economy of PH8 is based on a mix of tourism, farming and forestry, local businesses and third sector and services activities.

Tourism is one of the most significant contributors with historical landmarks, natural beauty, and cultural events drawing visitors year-round and playing a key role in shaping the local economy. Businesses, including hotels, bed and breakfasts, restaurants, cafes, and independent shops, benefit greatly from the influx of tourists, creating jobs and supporting a range of service industries, such as tour guides and outdoor activity providers as well artists and makers living and working locally. Musicians live and record in the area, and there is a thriving music scene in Birnam Arts, the local pubs and at two of the outlying village halls generating income for businesses and enjoyment for visitors and residents alike.

Forestry is another key economic activity with surrounding woodlands, managed for sustainable timber production, providing jobs in timber harvesting, wood processing, and related industries as well as giving recreational value for visitors. Inver includes the district headquarters of Forestry and Land Scotland and there are two large sawmills on the north edge of Dunkeld.

Livestock and arable farming contribute to local food production and employment and there is a growing trend toward sustainability and locally sourced food in the area with many smaller farms and food producers focusing on regenerative and organic practices.

A range of local businesses and third sector activities further contribute to the economic diversity of the area. Accommodation for some is provided via industrial units located in both Dunkeld and Birnam plus a coworking space in Little Dunkeld. The units at Birnam are however under threat from the A9 dualling plans.

Connectivity plays a crucial role in supporting the economy of the PH8 area and Dunkeld & Birnam benefit from their close proximity to the A9 and the Highland Mainline station in Birnam.



Community Consultation Engagement & Response

Several community volunteers, led by the Chair of DBDCDT, and including a representative from DBCC, met with Andrew Ballantine and Alasdair Finlayson from PKC Planning on Wednesday 5th June 2024 to discuss the possibility of preparing a PH8 LPP for our community.

After that meeting, it was agreed to progress this LPP as an update to the CAP developed in 2022, to progress feedback on how to deliver on the six key themes identified in that plan, and to provide community input into the 2027 LDP. The team has met on average fortnightly since that time in the development of this report.

Community Engagement

Community engagement was begun at the Birnam Highland Games in August, through 'The Bridge' community newspaper and then a wide-ranging LPP Questionnaire (Appendix 1) was released to the PH8 community in November 2024. As well as being available online, with links to it advertised from the DBCC Facebook page and the DBDCDT website, hardcopy questionnaires were delivered to all households in PH8 as inserts in the Dec/Jan edition of 'The Bridge'.

A closing date of 31st January was announced. Overall, 145 completed returns were received, approximately 16% of the 16+ population of Dunkeld and Birnam, or approximately 25% of households, as recorded in the 2022 Census.

While the young / single demographic is slightly under-represented, there is good overall correlation of age groups represented in the survey with the 2022 Census profile.

Questionnaire Response & Draft LPP Community Consultation Events

As well as numeric satisfaction scoring for each of the six CAP priorities, respondents were encouraged to provide free format textual answers, to gather as wide a range of feedback as possible from the community. These answers resulted in more than 600 distinct concerns and potential solutions being identified by the 145 respondents.


All these detailed responses are captured in <u>Appendix 2</u>, scored under the six CAP themes, subdivided into a total of 36 individual topics and sorted by frequency of response. Some of these topics contain place-based responses which are directly relevant to the LPP.


As well as informing this LPP, the results will provide the DBDCDT, the DBCC and other community focus groups with invaluable insight into community priorities and projects going forward, at a greater level of detail than from the original CAP.


This report, highlighting community priorities, was presented as a final draft at two community engagement events on 26th & 28th March 2025. Attendees were encouraged to leave comments, but none were received that challenged the major conclusions of the report, which remains as originally drafted.


Questionnaire Results

An initial analysis of the demographics of the survey returns shows residential status, length of residency, age range and household compositions.









Questionnaire Results

According to the media, PH8 is one of the most desirable locations to live. This is very much due to the stunning geography, precious natural ecosystems and significant human history. The survey results confirm this, with so many of us happy to live here. These are also the factors that draw so many visitors. Residents however can point to another reason - community.

The factors that make our neighbourhoods so desirable also constrain our community. Whilst PH8 area is very large, nearly everything must pass through the pinch points of Dunkeld and Birnam. Outlying settlements are interwoven into these constraints. We cannot escape geography, nature and history - it influences everything that happens here.

So what of the future? How do we have a *livable*, *sustainable* and *productive* place? How do we get the balance right? We will need many things but foremost we must cherish the community that is now, that was and that will be. Why? Well the word that was most used when describing what people liked was... Community.



Key feedback from the community

Two CAP priority areas dominate the community's concerns: CAP Theme 1: Active Travel and CAP Theme 2: Housing.

Out of the 17 distinct concerns raised by 20% or more of respondents, 11 of these relate to Active Travel, 4 to Housing, 1 to History/Heritage/Community and 1 to A Thriving Local Community.

Road traffic in Dunkeld & Birnam and parking in Dunkeld are the two single most-mentioned issues, closely followed by the A9 and its junctions at Dunkeld & Birnam. Specific concerns are road traffic congestion, pedestrian and active travel safety, road safety and growing levels of traffic congestion to and from the A9 and through Dunkeld over the Telford Bridge to Bridge & Atholl Streets. Access to, and future use of, the Railway Station building was also a common item raised.

The potential solutions to these problems most identified by the community are provision of new footbridges over the rivers Tay and the Braan, maintenance and development of footpaths and cycle paths, traffic calming / reduction measures to protect the Telford Bridge and the centre of Dunkeld and the creation of more parking capacity on the edge of the town. These are fully detailed in Appendix 2, Topics 7 to 12.

The PH8 community is dealing with complex local and national roads infrastructure issues, which will not be straightforward to resolve.

The DBCC have an active focus on local traffic and parking issues with PKC, and these results will help to inform their priorities in this area.

The A9 Community Group continue to engage with Transport Scotland (TS) on the final dualling and junction's design. The Scottish Government (SG)'s timetable has continually slipped, but if they meet their current plan to complete dualling of the A9 between Pass of Birnam and Tay Crossing by the end of 2032, this would be roughly halfway through the life of the next 2027 Local Development Plan.

The community's Junctions Action Group are also engaged in efforts to persuade TS to introduce interim safety measures at the junctions.

Acknowledging the lack of affordable housing in the community was the third-largest overall community issue after Traffic and Parking. The supply of affordable housing supply for local young people & families and local / key workers was specifically identified as a concern.

Several possible sites and ideas for affordable housing within the existing footprint of Dunkeld and elsewhere in PH8 were identified in the survey by a small number of people (details in Appendix 2, Topic 15), which may help to inform the work of the Community Housing Group.

43% of respondents to the Housing question stated that any new major housing development in Dunkeld would put too much pressure on town infrastructure / traffic / local services / natural and historic environment.

Given that the proposed major development at Haughend farm is a key place-based issue for the community and for this Local Place Plan, the number of respondents who explicitly referred to such a development was counted and their views analysed:

6 respondents fully supported the proposal, 2 supported only community housing at Haughend, but not the current larger development proposal, and 49 respondents opposed the development entirely.

There was concern expressed in the Historic, Heritage, Culture & Community section of the questionnaire for Dunkeld Cathedral (22%), with many respondents expressing frustration with Historic Scotland's progress in protecting this nationally important structure.

Major conclusions

The LPP survey results indicate that Traffic, Parking, Road and Active Travel Safety concerns remain the community's greatest priority. The A9 community co-creative process with TS has absorbed a great deal of goodwill and energy from members of the community, but the potential benefits to local people are at least another seven years away. It is incumbent upon PKC and TS to assist local community representatives in the DBDCDT, DBCC, and other engaged groups such as the Junction Action Group, to find ways to mitigate these issues as a matter of urgency.

Parking and active travel safety & infrastructure were also key concerns, but current progress to deliver an upgraded, modern and fully accessible railway station will be a real boost both for local commuters and visitors and has been supported and welcomed in the survey results

There is strong support for the provision of more affordable housing, but many respondents want to see this in a way that respects the existing settlement boundaries of Dunkeld and Birnam, and not as part of large commercial housing developments out-with these boundaries. There are clear concerns that such developments would exacerbate the already critical infrastructure issues the community experiences. Assistance from PKC to identify possible sites within PH8, funding sources, and to review Council housing allocation policy, is very important to these efforts.

The LPP survey generated many community suggestions and ideas, covering better community resilience, community renewable energy development, local economic growth, and better protection for our natural and historic environments. It is hoped that through the LPP community engagement events and the Next Steps process, the PH8 community will be able to take forward many of these ideas, towards the future vision of a successful but more sustainable and resilient community.

Input into LDP3

Through this LPP report, supported by the **Infrastructure First** policy principle in the SG National Planning Framework 4 (Appendix 3), the community strongly requests that the existing Settlement Boundaries for Dunkeld and Birnam are respected in the 2027 Local Development Plan.

The questionnaire response has delivered a rich insight into the community's concerns and suggestions for improvement. Nine potential Action Areas have initially been identified for detailed follow-up, some already very active, others less so. The follow-up community consultation events for the draft LPP report will provide an opportunity for further engagement, identification of interested volunteers, and future coordination of an overall action plan under the DBDCDT.

"Both pedestrian and car crossings of the A9 from Bankfoot to Dunkeld could be improved."

"The other routes in and out of the town are dangerous too, with the Boat Road not wide enough for the lorries and buses that use it."

"Concern that on many weekends/ sunny spells/ public holidays, Dunkeld & Birnam is suffering 'over-tourism' with congested roads, overfull carparks and sometimes dangerous verge parking on the A9(!!!). As a local resident I try to anticipate these days and avoid going into the village."

"Increased car parking, if a site was available, may help - but might equally increase the 'problem'."

"The path to the War Memorial is a disgrace." "If a Tay foot bridge cannot be built, make the bridge pavements one way like during Covid."

"A lack of pedestrian refuge along stretches of the A822 which, when they coincide with bends, puts walkers at risk of being hit by traffic e.g. around Trochry - Corbenic or around the Ladywell forest entrance."

"The Telford bridge is unsafe for elderly residents and children, something needs to be done to make it safer." "Good access to urban and rural spaces but could do more for cyclists on roadways." "Make the NCN route to Dalguise safer where it goes along-side the A9 on the Tay bridge crossing and along the B898 where the speed limit should be reduced and warning signs about cyclists installed."

"Cheaper housing for young people is needed. But this is the same everywhere. While some small-scale affordable housing within PH8 would be good (perhaps in neighbouring locations such as Inchmagrannachan, Dalguise, Trochry, Inver, etc) it should not add population to Dunkeld, which is already over-heated."

"There are not many vacant and unused spaces, but the largest is perhaps the derelict 2 acre field between the old nursery and Atholl St. This area is part unused field in the process of reverting to scrub and partly neglected forestry. It belongs to Atholl Estates I assume and there would be space for some 20 houses with easily constructive pedestrian access to the village."

"I firmly believe that the community could achieve affordable housing that prioritises those living and working here by building new, purchasing existing properties and securing tenancies in existing properties."

"Dunkeld's community spirit is slowly diminishing. We used to have gala days and duck races for the community, now we have the games and Santa day which is focused on tourists, which of course we need for our village to survive. Housing is a major issue, too many local families are being forced out."

"With the infrastructure we have, we need to be very careful to limit and manage development, putting watertight restrictions in place."

"Insufficient affordable housing for young families who are the future of the community."

"I'm not in favour of rezoning vast areas of land within this National Scenic Area that are not contiguous with our existing settlement boundaries. Proposals to do so, on land that could easily support a whole new community village, should not be permitted and there is surely nothing in current planning policy NPF4 that would support this."

"Maintaining current LDP settlement boundaries to prevent unwanted and unnecessary development (e.g. Erigmore Estate extension, Haughend commercial property development)"

"Glad that the transfer from NTS to PKC means there is more affordable housing. I am happy that PKC council (including some of our local councillors) voted against enforcing the restrictions on holiday home numbers."

Community Consultation Events on Draft Local Place Plan

Two community consultation events were held: at the Duchess Anne in Dunkeld on 26th March from 2pm to 7pm; and at the Guide Hall in Little Dunkeld from 12 noon until 7pm.

These events were advertised through the DBCC Facebook page, the DBDCDT website and via a series of posters displayed around Birnam and Dunkeld. Individual invitations were sent to Local Councillors and to members of the Development Trust.

The entire draft report and detailed survey results were displayed for viewing and comments. Volunteers from the LPP team and trustees from DBDCDT were on hand to guide attendees as necessary and to answer detailed questions.

Around 90 members of the community attended these events. They were encouraged to write comments on Post-It notes and affix them to the relevant pages of the report.

Some of these comments highlighted minor corrections to the draft, or suggested improvements to the presentation, and these have now been incorporated into this final report. Many comments were follow-up suggestions to the Next Steps section, and these have all been captured and added as Appendix 4.

The newly-formed Community Energy group also provided a separate opportunity for members of the community to express their views on which types of renewable energy initiatives might be progressed. These results are also included in Appendix 4.

There were many verbal statements of appreciation and support for the process, and the contents and presentation of the report. No comments were received challenging the major conclusions of the report, which remains as originally drafted.
